

MEMBERSHIP AFFIRMATION
AND
PLEDGE CARD

SOUTH FLORIDA QUARTER HORSE ASSOCIATION, INC.

I, _____, a () horse owner () trainer, () jockey, or () representative of SFRA, hereby affirm that I am a member of **SOUTH FLORIDA QUARTER HORSE ASSOCIATION, INC.** ("SFQHA"), who shall be at Hialeah Park, including during its quarterhorse meets, and shall be participating in the racing to be conducted at Hialeah Park. As a member of SFQHA, I hereby designate, appoint and authorize SFQHA to exclusively represent me in, and hereby ratify any and all negotiations and agreements with **SOUTH FLORIDA RACING ASSOCIATION, LLC dba HIALEAH PARK** ("Hialeah"), with regard to all matters regarding quarterhorse meets to be conducted at Hialeah Park, specifically including the negotiation and execution of an agreement regarding the payment of purses, other statutory approvals and the receipt or dissemination of interstate simulcasting under applicable state and federal law, as such laws may be amended from time to time. I also authorize SFQHA to receive all purse funds from Hialeah, to reimburse expenses incurred by SFQHA from purse funds, and to pay out the purses, and hereby release and hold harmless Hialeah with respect to SFQHA's handling and disbursement of all purse funds. I also authorize SFQHA to agree on my behalf to the terms of Hialeah's House Rules, as amended from time to time, and acknowledge and agree that I am bound by the terms of the House Rules. The authorization granted by this Membership Affirmation and Pledge Card (the "Pledge Card"), shall be exercisable by SFQHA in connection with all of Hialeah's licensed race meets conducted, in part or in their entirety, after the date that the undersigned executed this Pledge Card (collectively the "Applicable Race Meets").

I hereby revoke any and all prior authorizations of representation that I may have expressly or implicitly given to any other horsemen's association to represent me in connection with any and all negotiations and agreements **with Hialeah** with regard to the payment of purses, other statutory approvals and the authorization for the receipt or dissemination of interstate simulcasting during the Applicable Race Meets.

This authorization of representation shall continue in full force and effect until 180 days after I have revoked the authorization herein contained in writing and such written revocation has been received by SFQHA by certified mail, return receipt requested. I agree that any future authorizations that I may give to any other horsemen's association to represent me in any capacity shall not be effective, or supersede or diminish the authorization of representation hereby granted to SFQHA with regard to the negotiations of all matters and execution of agreements with Hialeah until after the effective date of any revocation of this exclusive grant of authority.
